



# Aircraft Rental Agreement

This Agreement is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_\_, between \_\_\_\_\_, residing at \_\_\_\_\_, hereinafter called "**User**" and Corby Corporation, Inc. d/b/a **Nebraska Flight Center**, 3737 Orville Plaza, Omaha, NE 68110, a Nebraska Corporation, hereinafter referred to as "**FBO**".

The **User** is making application to **FBO**, to use the aircraft that the FBO has available for rental use, and such application has been duly approved by **FBO**.

In consideration of the covenants, terms and conditions of this agreement, and as long as the **User** is current in the payment of all dues and charges billed to the **User**, it is mutually agreed that:

1. **User** shall be entitled to use the aircraft in accordance to the rules and regulations provided herein at such times as the **User** may require and the aircraft use schedule allows.
2. It is agreed by **User** that he/she will indemnify, protect and hold harmless **FBO**, from all claims, demands, causes of actions, suits or costs whatsoever asserted by any person, firm or corporation arising from the operation of the aircraft by **User**, specifically including but not limited to, operation in violation of any **United States Federal Aviation Regulations** or other **Federal, State** or **local** laws or regulations, or **Nebraska Flight Center's Safety and Operating Procedures and Practices**.
3. **User** is emphatically encouraged to secure and obtain Renter's Insurance coverage and shall provide **FBO** with proof of current insurance, or initial here \_\_\_\_\_ to acknowledge **User** understands that **FBO's** insurance may not cover **User** under certain circumstances at the insurance company's discretion.
4. **User** further agrees to pay **FBO**, in advance or immediately after each flight, for the aircraft rental and any other costs as included in the latest **FBO** Schedule of Equipment Rates, which is subject to change by **FBO** from time to time upon notice to **User**.
5. In the event that **User's** financial obligations to **FBO** are not met in a timely manner, **User** shall pay **FBO** reasonable attorney fees for collection in an amount no less than 15% of the total of the **User's** unpaid balance.
6. **User** shall pay a maximum finance charge of 1.75% per month (an annual percentage rate of 21%) on the balance of **User's** financial obligation to **FBO** that remains unpaid one month after the date of **FBO's** statement of the **User's** account.
7. It is agreed that **User** will be denied the use of our aircraft and other services until **User's** account is brought current with **Nebraska Flight Center**.
8. This agreement shall be binding upon the heirs, legal representatives and successors of the parties hereto.
9. **User** hereby agrees to adhere to the United States Federal Aviation Regulations and to the **Safety and Operating Procedures and Practices** for **Nebraska Flight Center** as they may be amended from time to time. The **Safety and Operating Procedures and Practices** for **Nebraska Flight Center** are incorporated herein by reference as is fully set forth therein.
